HIGHLIGHTS OF BOTH PROGRAMS

- Strong tradition of excellence in legal education William & Mary is the first law school in the United States (established 1779)
- Outstanding faculty includes prominent legal scholars, subject matter experts, and leading practitioners
- Access to career resources and William & Mary's extensive alumni network in every state in the U.S. and over 50 countries worldwide
- Curriculum is customizable to meet U.S. Bar Exam requirements
- Events hosted throughout the year (both in-person and virtual) with professors and lawyers from corporations, law firms, NGOs and the judiciary

RESIDENTIAL PROGRAM (FULL-TIME)

- Completed in one academic year (two consecutive semesters)
- Earn 24 credits total with one requirement (Legal Writing & Research)
- Option to apply for a third semester to earn an Advanced Specialization in Business & Corporate Law, International Law, Intellectual Property, Constitutional Law, Criminal Law, or Methods of Dispute Resolution
- All law classes taught in-person (in the law school building)
- Students can take law classes to prepare them to take a U.S. bar examination or take courses of interest based upon their educational and career goals
- Many in-person LLM students choose to take a U.S. Bar Exam after graduation. The most common jurisdictions are NY, CA, DC, and TX
- Williamsburg, VA is an affordable community with high quality of life amenities, including a graduate student housing facility next to the law school

100% ONLINE PROGRAM (PART-TIME)

- Completed part-time in less than 24 months studying year-round (4 semesters including summer)
- Earn 25 credits with two requirements Legal Writing & Research and Professional Responsibility law courses. Recommended course offerings include Business Associations, Civil Procedure, Contracts, Criminal Law, Evidence, Property, Torts, and U.S. Constitutional Law
- Most courses incorporate exercises for students to gain practical experience in legal writing, research and fundamental lawyering skills that will support transactional or litigation-focused practices
- All courses are specifically designed for the online format and can be completed 100% asynchronously from any location in any time zone
- Opportunities are integrated throughout the curriculum to connect and interact live with professors and fellow students
- The online program curriculum meets the requirements for the three bar exam jurisdictions in the U.S. that accept online credits (CA, DC, WA). 3 additional credits are required for the DC Bar Exam
