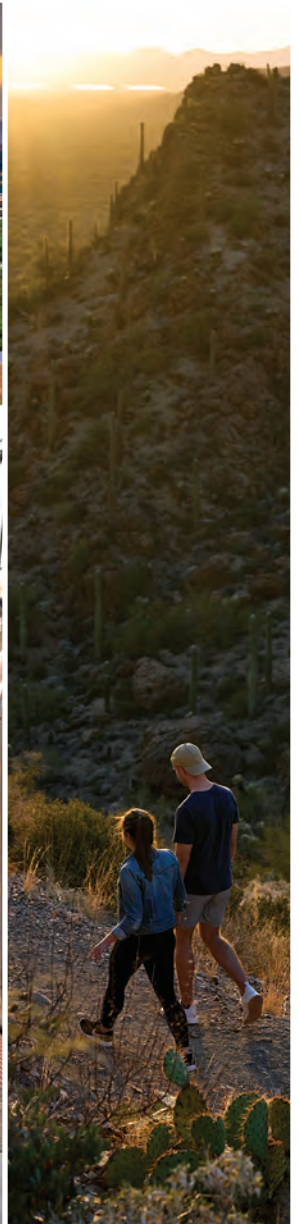

ELIGIBILITY REQUIREMENTS

To apply, you must:

- ▶ Hold a first degree in law (e.g., LLB or equivalent)
- ▶ Demonstrate English proficiency
 - ▶ TOEFL: 79 iBT or higher
 - ▶ IELTS: 7.0 or higher
- ▶ No LSAT or GRE required

APPLICATION DEADLINES

In-Residence Studies

- ▶ Fall Start: May 1
- ▶ Spring Start: October 15

Online Studies

- ▶ Fall A: July 1
- ▶ Fall B: September 1
- ▶ Spring A: November 1
- ▶ Spring B: January 1
- ▶ Summer A: March 1
- ▶ Summer B: April 1

TUITION (2025–26 ACADEMIC YEAR)

- ▶ In-Residence (1-year program): \$27,500
- ▶ Online: \$750 per credit (minimum 24 credits)
