The Student Law Office

The Student Law Office is an multi award-winning and world leading law clinic, offering vital legal services on a regional and national level. Since 2008 the Student Law Office has dealt with over 3000 enquiries, represented more than 1000 clients, and secured over £1 million on their behalf.

Our students integrate learning from experience with development of academic knowledge and research skills, all of which is heightened by the live client experience in which the motivation, reality and necessity of client service creates a powerful learning environment. The excellent teaching environment in the Student Law Office has been recognised by the Higher Education Academy, with the Student Law Office winning a Collaborative Award for Teaching Excellence (CATE).

Our Programmes

Students who enrol on our LL.B. and decide that they wish to qualify as solicitors have the option of transferring to our M Law degree. This is an integrated masters programme which incorporates knowledge and professional skills that will help students to pass key assessments set by the Solicitors Regulation Authority (the Solicitors Qualifying Examination) which they must take on their journey to becoming a solicitor.

We also offer the postgraduate Legal Practice Course for graduates who wish to qualify as solicitors and from 2023 will also offer an LL.M. in Professional Legal Practice to prepare graduates for stage 1 of the Solicitors Qualifying Examination.

We are one of only 10 institutions in England and Wales to provide the postgraduate Bar Course and the only institution to offer the M Law Bar Course which incorporates both the academic and vocational study required to qualify as a barrister. We offer a comprehensive range of law programmes and flexible modes of study to help our students become lawyers, professionals, and take their careers to the next level.

The LL.M. Law programme is part of Northumbria University's innovative and flexible framework, which will allow you to study for you with a specialism, such as those listed below.

LL.M. Law (International Commercial Law)

An increasingly globalised economy requires international commercial law professionals to have a wide range of knowledge on issues relevant to international commerce. This includes the World Trade Organisation and the law of international trade, and in areas such as international finance, intellectual property, or international energy law.

LL.M. Law (Cyber Law)

As technology rapidly evolves it can be a challenge for our legal systems to keep up. The Cyber Law specialism has been designed to meet the needs of cyber legal practitioners, as well as other professionals working in the technology field who may benefit from a deeper contextual understanding of the wicked problems in the commercial, security and military sectors.

LL.M. Law (Space Law)

As nations grapple with the enormity of the task of regulating outer space, all those working in the space sector require an understanding of geopolitics, advanced skills in policy analysis and awareness of the limits and legal constraints on human space exploration. Studying Space Law will equip you with enviable knowledge and skills at the frontiers of legal research, and staff at Northumbria are among the UK's foremost authorities on the subject.

LL.M. Law (Criminal Justice)

The programme has been designed to meet the needs of legal practitioners, policy makers and other professionals who currently work, or hope to work in the field of criminal justice. This offers an exceptional opportunity to gain career enhancing knowledge and skills which can be applied to a wide range of careers thus it is an excellent opportunity for existing barristers, solicitors, and forensic practitioners, those in the fields of rehabilitation, the police service, private investigation across the public, private and volunteer sectors as well as PhD study.

LL.M. Law (International Criminal Law and Practice)

The course emphasises practical skills and how to overcome dilemmas frequently experienced by practitioners in client-facing and litigation settings, as well as examining the procedural difficulties that tribunals such as the International Criminal Court often face.
